I am writing on behalf of Ryan & Renee Mobbs of PR&R Development, LLC to formally request a Final Plat hearing for a proposed Eight-Lot Subdivision and Planned Unit Development relative to their existing 61.26± acre parcel of land located at Observatory Road in Hinesburg. The parcel is currently improved with and/or permitted for a 4-bedroom single-family residence with a 2-bedroom accessory dwelling unit, gravel drive, drilled well and on-site wastewater disposal system. PR&R Development, LLC is proposing to subdivide the 61.26± acre parcel to create the following eight (8) new parcels:
