Town Common Committee Meeting Minutes October 24, 2023 Approved December 19, 2023

AJ Driscoll called the meeting to order at approximately 7:00 PM.

1. Agenda Changes - none.

- 2. Minutes of Prior Meeting Lenore motioned to approve the minutes from Sept 26, Maggie seconded. Minutes approved by voice vote.
- 3. Brief updates on progress
 - Engineering RFP responses and next steps:
 - Received two responses; cost estimates were \$32,000 and \$49,000; lower cost estimate from Dubois-King (same firm that did the conceptual design); Select Board authorized spending \$32,000 of ARPA funds to move forward with the engineering; this is engineering for just phase 1 i.e., earthwork, drainage, landscaping, rain gardens and overall stormwater runoff modeling.
 - Contract negotiation will include when to start and how long project will take.
 DuBois and King want to schedule a meeting with the TCC. Alex to see if they can attend Dec. meeting.
 - Maggie raised concern about getting Act 250 permit in time to begin work next spring/summer. Act 250 office wants to see clean plan with what's happening in which phase. Alex suggested signing contract and waiting to begin work until after neighborhood meeting. Doesn't see problem with getting permit. DRB will also need to review.
 - Lenore is hoping electrical/water service is included in this sitework.
 - Maggie questioned what berms should look like.
 - Urban & Community Forestry Grant application status:
 - Grant to plant trees. Maggie and Lenore put together a draft. Need Todd Odit to look at. Should maintenance of Creekside trees go into same grant as Town Common? Paul Wizorak looked at Creekside trees and seemed to think they were in good health and mainly needed trimming.
 - Need Town Tree Warden, Paul Wieczoreck, to weigh in on how many trees need to be planted/how big. Can we plant with volunteer support?
 - Marie Ambusk wants to be involved in tree planting. She is an expert on tree roots.
 - ARPA and Town budget requests:
 - Selectboard approved \$32,000 for engineering plans.
 - There's \$17,500 in budget for Town Common project now. Will advocate for 10,000 capital reserve from Selectboard at Nov 8 meeting.

- Alex will bring over conceptual design and visuals and will give a brief summary of the project.
- AJ has been talking up the meeting and will send out neighborhood email.

 Parkside Cafe or leave door hanger. Post to Front Porch Forum.
